


2. Law Day / Constitution Day

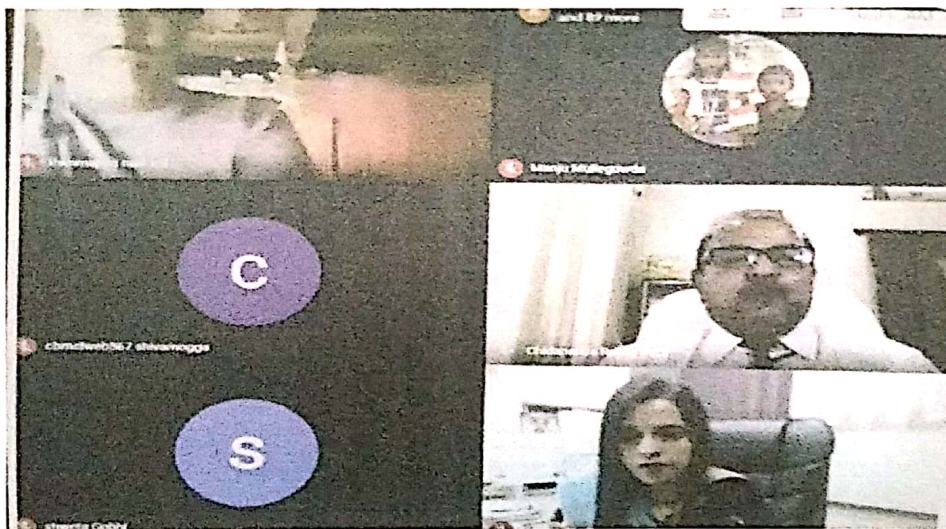
